### **Exhibitor Admission**

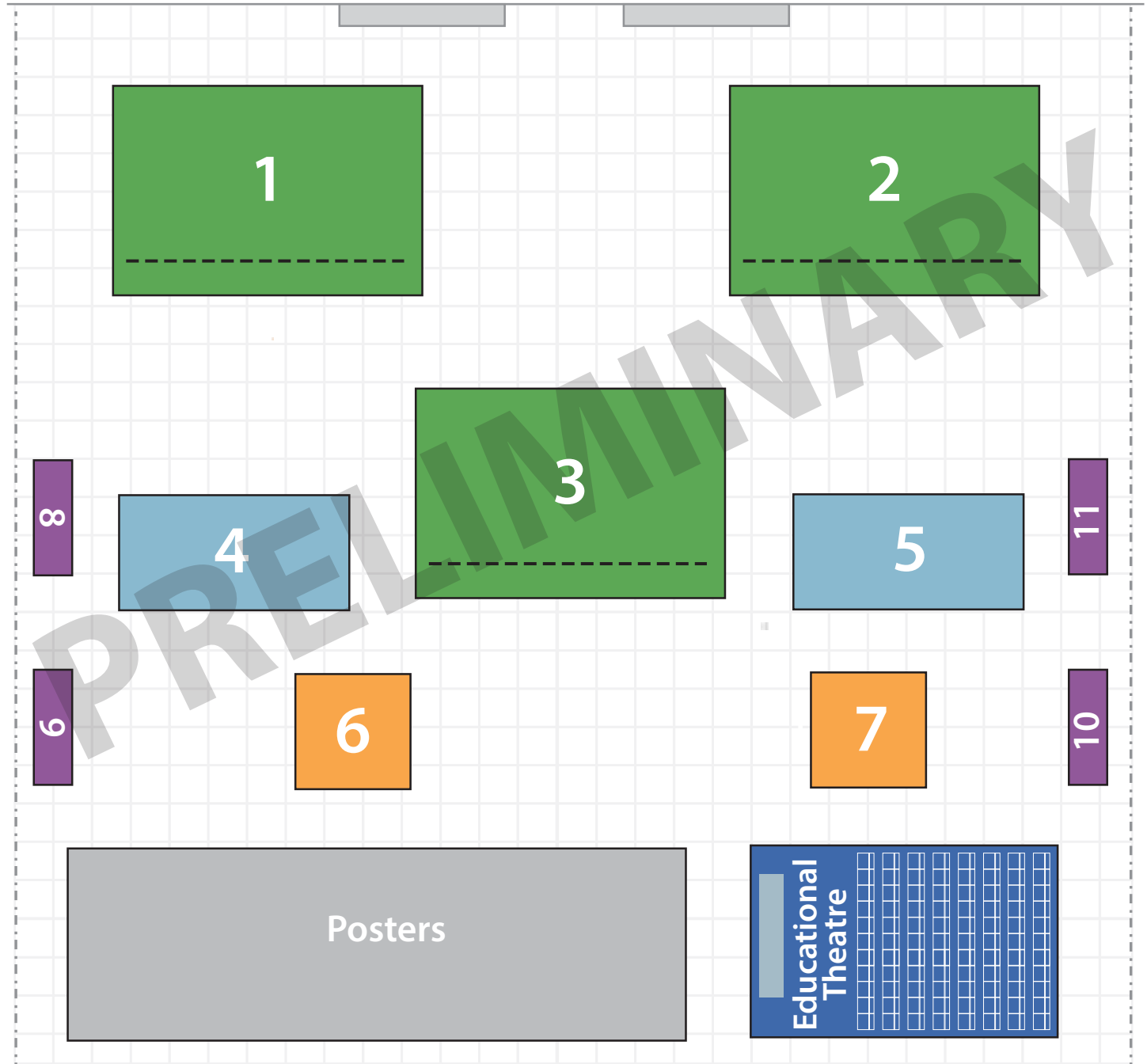
